A resolution providing for canvassing the returns and declaring the results of the special elections held in (i) the Parish of Sabine, State of Louisiana, (ii) Road District No. 18, Ward 1 of Sabine Parish, Louisiana, (iii) Road District No. 16, Ward 2 of Sabine Parish, Louisiana, (iv) Road District No. 9, Ward 3 of Sabine Parish, Louisiana, (v) Road District No. 17, Ward 4 of Sabine Parish, Louisiana, (vi) Road District No. 20, Ward 9 of Sabine Parish, Louisiana and (vii) Road District No. 11, Ward 10 of Sabine Parish, Louisiana, on Saturday, April 29, 2017, to authorize the levy of special taxes therein.

Shall the Parish of Sabine, State of Louisiana (the "Parish"), levy a one and sixty-seven hundredths (1.67) mills tax on all the property subject to taxation in the Parish (an estimated \$288,000 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of ten (10) years, beginning with the year 2019 and ending with the year 2028, for the purpose of acquiring, constructing, improving, maintaining, operating, providing and/or supporting an animal shelter for or on behalf of the Parish, including facilities, equipment, services and programs provided by the Sabine Humane Society, Inc., said millage to represent a seventeen hundredths of a mill (.17) increase over the 1.50 mills tax authorized to be levied through the year 2018 pursuant to an election held on November 4, 2008?

**ROAD DISTRICT NO. 18, WARD 1
PROPOSITION (TAX CONTINUATION)**

Shall Road District No. 18, Ward 1 of Sabine Parish, Louisiana (the "District"), levy a ten and ninety hundredths (10.90) mills tax on all the property subject to taxation within the District for a period of ten (10) years, beginning with the year 2019 and ending with the year 2028 (an estimated \$168,950 reasonably expected at this time to be collected from the levy of the tax for an entire year), for the purpose of constructing, improving, maintaining and/or repairing public roads and bridges in the District, including ditching and drainage therefor and purchasing of equipment therefor, said millage to represent a sixty hundredths of a mill (.60) increase over the 10.30 mills tax authorized to be levied through the year 2018 pursuant to an election held on February 9, 2008?

PROPOSITION (TAX RENEWAL)**

Shall Road District No. 9, Ward 3 of Sabine Parish, Louisiana (the "District"), levy a ten and twenty-five hundredths (10.25) mills tax on all the property subject to taxation within the District for a period of ten (10) years, beginning with the year 2019 and ending with the year 2028 (an

estimated \$217,430 reasonably expected at this time to be collected from the levy of the tax for an entire year), for the purpose of constructing, improving, maintaining and/or repairing public roads and bridges in the District, including ditching and drainage therefor and purchasing of equipment therefor?

**ROAD DISTRICT NO. 17, WARD 4
PROPOSITION (TAX RENEWAL)**

Shall Road District No. 17, Ward 4 of Sabine Parish, Louisiana (the "District"), levy a ten and forty-one hundredths (10.41) mills tax on all the property subject to taxation within the District for a period of ten (10) years, beginning with the year 2019 and ending with the year 2028 (an estimated \$358,960 reasonably expected at this time to be collected from the levy of the tax for an entire year), for the purpose of constructing, improving, maintaining and/or repairing public roads and bridges in the District, including ditching and drainage therefor and purchasing of equipment therefor?

**ROAD DISTRICT NO. 20, WARD 9
PROPOSITION (TAX CONTINUATION)**

Shall Road District No. 20, Ward 9 of Sabine Parish, Louisiana (the "District"), levy a twenty-two and sixteen hundredths (22.16) mills tax on all the property subject to taxation within the District for a period of ten (10) years, beginning with the year 2019 and ending with the year 2028 (an estimated \$70,910 reasonably expected at this time to be collected from the levy of the tax for an entire year), for the purpose of constructing, improving, maintaining and/or repairing public roads and bridges in the District, including ditching and drainage therefor and purchasing of equipment therefor, said millage to represent a ten and forty-three hundredths mills (10.43) increase over the 11.73 mills tax authorized to be levied through the year 2018 pursuant to an election held on November 4, 2008?

**ROAD DISTRICT NO. 11, WARD 10
PROPOSITION (TAX CONTINUATION)**

Shall Road District No. 11, Ward 10 of Sabine Parish, Louisiana (the "District"), levy a twenty-five and sixty-four hundredths (25.64) mills tax on all the property subject to taxation within the District for a period of ten (10) years, beginning with the year 2019 and ending with the year 2028 (an estimated \$403,600 reasonably expected at this time to be collected from the levy of the tax for an entire year), for the purpose of constructing, improving, maintaining and/or repairing public roads and bridges in the District, including ditching and drainage therefor and purchasing of equipment therefor, said millage to represent an eight and ninety hundredths mills (8.90) increase over the 16.74 mills tax authorized to be levied through the year 2018 pursuant to an election held on February 9, 2008?

There was found by said count and canvass that the following votes had been cast at the said special election **IN FAVOR OF** and **AGAINST**, respectively, the propositions as hereinabove set forth:

(i) there was a total of **1,063** votes cast **IN FAVOR OF** Parishwide Proposition and a total of **802** votes cast **AGAINST** Parishwide Proposition, as hereinabove set forth, and that there was a majority of **261** votes cast **IN FAVOR OF** Parishwide Proposition as hereinabove set forth;

(ii) there was a total of **108** votes cast **IN FAVOR OF** Road District No. 18, Ward 1 Proposition and a total of **89** votes cast **AGAINST** Road District No. 18, Ward 1 Proposition, as hereinabove set forth, and that

there was a majority of **19** votes cast **IN FAVOR OF** Road District No. 18, Ward 1 Proposition as hereinabove set forth;

(iii) there was a total of **65** votes cast **IN FAVOR OF** Road District No. 16, Ward 2 Proposition and a total of **54** votes cast **AGAINST** Road District No. 16, Ward 2 Proposition, as hereinabove set forth, and that there was a majority of **11** votes cast **IN FAVOR OF** Road District No. 16, Ward 2 Proposition as hereinabove set forth;

(iv) there was a total of **162** votes cast **IN FAVOR OF** Road District No. 9, Ward 3 Proposition and a total of **94** votes cast **AGAINST** Road District No. 9, Ward 3 Proposition, as hereinabove set forth, and that there was a majority of **68** votes cast **IN FAVOR OF** Road District No. 9, Ward 3 Proposition as hereinabove set forth;

(v) there was a total of **429** votes cast **IN FAVOR OF** Road District No. 17, Ward 4 Proposition and a total of **364** votes cast **AGAINST** Road District No. 17, Ward 4 Proposition, as hereinabove set forth, and that there was a majority of **65** votes cast **IN FAVOR OF** Road District No. 17, Ward 4 Proposition as hereinabove set forth;

(vi) there was a total of **41** votes cast **IN FAVOR OF** Road District No. 20, Ward 9 Proposition and a total of **20** votes cast **AGAINST** Road District No. 20, Ward 9 Proposition, as hereinabove set forth, and that there was a majority of **21** votes cast **IN FAVOR OF** Road District No. 20, Ward 9 Proposition as hereinabove set forth; and

(vii) there was a total of **31** votes cast **IN FAVOR OF** Road District No. 11, Ward 10 Proposition and a total of **5** votes cast **AGAINST** Road District No. 11, Ward 10 Proposition, as hereinabove set forth, and that there was a majority of **26** votes cast **IN FAVOR OF** Road District No. 11, Ward 10 Proposition as hereinabove set forth.

Therefore, the Governing Authority did declare and proclaim and does hereby declare and proclaim in open and public session that the Parishwide Proposition, Road District No. 18, Ward 1 Proposition, Road District No. 16, Ward 2 Proposition, Road District No. 9, Ward 3 Proposition, Road District No. 17, Ward 4 Proposition, Road District No. 20, Ward 9 Proposition and Road District No. 11, Ward 10 Proposition as hereinabove set forth were duly **CARRIED** by a majority of the votes cast by the qualified electors voting at the said special elections held in the Parish and respective Districts on Saturday, April 29, 2017.

Since the search for a replacement from the Florien area has been unsuccessful, the Police Jury will now expand its search to all areas of the Parish.

Mr. Bobby Gibson, originally hired as an equipment operator for Ward 1, has requested to be, and has been transferred by the Parish Road Superintendent to the position of a fill-in compactor worker. This transfer has left an opening for an equipment operator for Ward 1.

Parish Road Superintendent Olivier stated that he intends to begin the 2017 road asphaltting program within the next few weeks.

Mr. Olivier reported that the majority of required bridge repairs have been completed.

On May 11, 2017, the Police Jury received a request from the Friends of Fort Jesup Historical Site for permission to host a parade on Saturday, June 3, that would start at the Fort Jesup ball park, travel down Geoghagan Road, in front of the fort, turn and go to the Nazarene Campground, and then loop back down the route back to the ball park. The parade would start at 10:00am and last about one half of an hour.

Mr. Brown has discussed the proposed parade with Mr. Scott DeBose and mentioned to him that the Friends of the Fort Jessup Historical Site would need to obtain a police escort for the front and back of the parade and would need to obtain liability insurance naming Sabine Parish as an additional insured.
