1. Call to Order

President Ronald L. Bison called the meeting to order.

2. Roll Call

The roll was called by the Secretary Treasurer. The following jurors were present: Willes Funderburk, Mike McCormic, "Charlie" Brown, William E. Ruffin, "Ronny" Bison, Eric Garcie, Ricky "K-Wall" Sepulvado, and Kenneth M. Ebarb..

The following member arrived late: "Randy" Byrd

3. Prayer

Prayer was led by Mr. William E. Ruffin.

4. Pledge of Allegiance

The Pledge of Allegiance was led by Mr. Charlie Brown.

5. Amend the Agenda

There was no amendment to the agenda.

Police Jury President, Ronald L. Bison, allowed a period of public comment on any item on the agenda. Mr. Bison advised everyone that they would be allowed to comment later during the meeting on particular agenda items, if they desire. There were no public comments at this time.

7. Accept the Minutes of the Previous Regular Meeting, January 16, 2019

8. Planning Commission

No member of the Sabine Parish Planning Commission was present.

9. Rescind Resolution 8206 of 2018

On December 19, 2018, the Sabine Parish Police Jury adopted Resolution No. 8206 which increased the monthly pay for police jurors by four hundred dollars (\$400.00) to twelve hundred dollars (\$1,200.00) per month for jurors and to one thousand three hundred dollars (\$1,300.00) per month for the president of the police jury.

Louisiana Revised Statute 33:1233 requires that proposed changes in the compensation paid to police jurors must be made by ordinance approved by a majority of the jurors in an open public meeting, after a public hearing which has been advertised in the official journal of the parish on at least two separate occasions within a period of fifteen days preceding the open meeting.

Resolution No. 8236

Motion by McCormic and seconded by Sepulvado to rescind Resolution No. 8206 which increased the monthly pay for police jurors by four hundred dollars (\$400.00) to twelve hundred dollars (\$1,200.00) per month for jurors and to one thousand three hundred dollars (\$1,300.00) per month for the president of the police jury.

10. Call Public Hearing to Consider Increase in Police Jurors' Salary

NOW, THEREFORE, BE IT RESOLVED, that a public hearing be held at the Sabine Parish Police Jury's regular meeting place, the Police Jury Meeting Room in the

Courthouse, 400 S. Capitol Street, Room 101, Many, Louisiana, on Wednesday, March 20, 2019 at Eight-Thirty (8:30) a.m. to consider increasing the monthly salary for police jurors to the amount of one thousand two hundred dollars (\$1,200.00) per month and increasing the salary of the police jury president to one thousand three hundred dollars (\$1,300.00) per month, and

BE IT FURTHER RESOLVED, that the public hearing be advertised in the official journal of the parish on March 6 and 13, 2019

13. Discuss Engaging a Grant Writer for the Sabine Parish Police Jury

Mr. Mike McCormic addressed the police jury concerning the need to engage a grant writer to assist the jury in obtaining additional grant funding for road and other infrastructure improvements. He and Mr. Kenneth Ebarb have met with Mrs. Susanne Williams and discussed how she could help the jury.

Mr. McCormic would like to authorize Mrs. Williams to research available grants and present them to the jury. The jury would then select the grants that they would like to pursue.

Resolution No. 8240

The following resolution was offered by Ebarb and seconded by Funderburk:

WHEREAS, the police jury wishes to pursue more grant funding for capital improvements to roads and other infrastructure, and

WHEREAS, the police jury believes that an experienced grant writer will significantly improve its ability to obtain available grant funding,

NOW, THEREFORE, BE IT RESOLVED that Mrs. Susanne Williams be engaged as a grant writer for the police jury at the hourly rate of thirty dollars (\$30.00) per hour, and

BE IT FURTHER RESOLVED that Mrs. Williams is hereby authorized to conduct up to forty (40) hours of research to identify grants that would benefit Sabine Parish, and

BE IT FURTHER RESOLVED that Mrs. Williams will write only those grants that are selected and approved by the police jury.

14. <u>Discuss Forming an Ad-Hoc Committee for Consideration of Industrial Tax Exemptions</u>

The Secretary Treasurer reported that the Finance Committee had recently met with representatives of the Tax Assessor's Office, the Sheriff's Office, and the School Board to discuss Industrial Tax Exemptions for businesses located in Sabine Parish. In the past, these tax exemptions were awarded by the State of Louisiana; however, in the future these exemptions will be granted by the affected local governing entities. Mr. Bison noted that these exemptions were previously granted without consultation with, or even notification of, the local governments.

Mr. Ruffin stated that previously granted exemptions and continuations will remain in affect as granted but all new industrial tax exemptions will be presented at the parish level for approval by the local government entities.

Mr. Ebarb recommended forming a committee to initially review the new industrial tax exemptions and to recommend a uniform response by the parish governing entities. Mr. McCormic suggested that there be a committee formed with two members each from the

police jury, the sheriff, and the school board. Police Jury committee members would be appointed by the president for five-year terms.

15. <u>Authorize President Bison to Enter a Cooperative Endeavor Agreement with the Town of Many to Overlay McFarland and Henry Streets</u>

The Town of Many, Louisiana and the Sabine Parish Police Jury would like to enter into a cooperative endeavor agreement to overlay McFarland and Henry Streets. The Town of Many has agreed to pay one half of the cost of overlaying the streets. The estimated costs of the project are as follows:

McFarland Street- \$35,000 Henry Street - \$13,000

Resolution No. 8241

Motion by Ruffin and seconded by Ebarb to authorize President Bison to execute a Cooperative Endeavor Agreement with the Town of Many, Louisiana to overlay McFarland and Henry Streets.

16. Establish Employment Position and Hire Solid Waste Site Manager

President Bison noted that the police jury has historically had problems with the waste compaction sites. These problems seem to result from a lack of maintenance. The road superintendent has been responsible for the maintenance of the compaction stations.

President Bison stated that he would like to remove this responsibility from the road superintendent to allow him to concentrate on road maintenance. Mr. Bison indicated that he would like to establish a part-time position to perform general maintenance of the compaction stations.

Resolution No. 8242

Motion by McCormic and seconded by Brown:

WHEREAS, the solid waste compaction stations have historically lacked adequate maintenance, and

WHEREAS, the employees operating the solid waste compaction stations have not always had effective supervision,

NOW, THEREFORE, BE IT RESOLVED, that a new employment position to address these issues be hereby authorized, and

BE IT FURTHER RESOLVED, that the Solid Waste Committee prepare a proposed job description for this position and recommend the rate of pay and the number of hours that the employee will be authorized to work, and

BE IT FURTHER RESOLVED, that the proposed job description, recommended rate of pay and hours of employment be presented to the full jury for approval.

17. To Adopt Chris Alford Road into the Parish-Wide Road System

Chris Alford Road, located in Ward 4, Road District 17, has been maintained by the police jury for many years and has been tacitly dedicated to the parish. It has been determined that the road meets the criteria to be adopted into the Parish Wide Road System.

Resolution No. 8243

Motion by Brown and seconded by Ruffin to adopt Chris Alford Road in Ward 4, Road District 17, into the Parish Wide Road System.

18. Abandon the Right-of-Way for South Cortez

Mr. McCormic explained to the Jury that a subdivision has been developed on Tonti Drive. The right-of-way for South Cortez; located in Ward 3, Road District 9, was planned and transferred to the Sabine Parish Police Jury. The subdivision has been completed without this road being constructed.

Mr. McCormic recommended abandonment of the right-of-way for South Cortez.

Resolution No. 8244

Motion by Ebarb and seconded by Funderburk to abandon the right-of-way for South Cortez located in Ward 3, Road District 9.

19. Abandon the Eastern 525 Feet of the Right-of-Way for Tonti Drive

Mr. McCormic explained to the Jury that a subdivision has been developed on Tonti Drive. The eastern 525 feet of right-of-way for Tonti Drive; located in Ward 3, Road District 9, was planned and transferred to the Sabine Parish Police Jury. The subdivision has been completed without these 525 feet of road being constructed.

Mr. McCormic recommended abandonment of the eastern 525 feet of right-of-way for Tonti Drive

Resolution No. 8245

Motion by Ebarb and seconded by Funderburk to abandon the eastern 525 feet of right-of-way for Tonti Drive located in Ward 3, Road District 9.

20. Approve New School Bus Turnaround at 277 Martinez Landing Road

The police jury has received a request from the Sabine Parish School Board, dated February 6, 2019, to build a new school bus turnaround at 277 Martinez Landing Road. Road Superintendent Hughes has examined the proposed site and estimates that the cost to construct the school bus turnaround will be approximately \$800.

Resolution No. 8246

Motion by McCormic and seconded by Sepulvado to construct a new school bus turnaround located at 277 Martinez Landing Road.

21. Approve New School Bus Turnaround at 1175 Pine Street

The police jury has received a request from the Sabine Parish School Board to build a new school bus turnaround at 1175 Pine Street. Superintendent Hughes has examined the proposed site and estimates that the cost to construct the school bus turnaround will be approximately \$2,570.

Motion by Sepulvado and seconded by Ebarb to construct a new school bus turnaround located at 1175 Pine Street.

25. Operations

Road Superintendent Hughes requested that an ordinance to reduce the speed limit on Brumley Road be placed on the agenda for the March meeting.

Road Superintendent Hughes requested the police jury to authorize hiring a temporary employee to fill the position of a full-time employee absent due to a long-term illness.

Resolution No. 8250

Motion by Ruffin and seconded by Byrd to authorize the Road Superintendent to hire a temporary employee working 45 hours per week at a regular rate of pay of \$11.61 per hour for a period which is the less of six months from date of hire or the return of the full-time employee whose position he is filling.

The voting was as follows:

Road Superintendent Hughes then discussed problems associated with hiring new employees. It was noted that new employees work a six-month probationary period. During this probationary period employees not performing well can be terminated. Mr. Hughes requested authority to terminate employees during their probationary period.

Motion by McCormic and seconded by Sepulvado to authorize the Road Superintendent to terminate employees working under his supervision during their six-month probationary period.
