12. Dr. Sarah Ebarb - Northwest Louisiana Human Services District

Dr. Sarah Ebarb presented a quarterly report on the activities of the Northwest Louisiana Human Services District. The District holds monthly meetings in Shreveport, Louisiana and provides services to individuals residing in Bienville, Bossier, Caddo, Claiborne, DeSoto, Natchitoches, Red River, Sabine and Webster Parishes. The District's Board of Directors consists of representatives from each of the parishes making up the District and three representatives appointed by the governor.

Dr. Ebarb noted that the District oversees the Behavioral Health Clinic located in Many, Louisiana. The District Court and the parish schools utilize services provided by the Clinic which is vital to Sabine Parish.

The goal of the Clinic is to provide service to the uninsured. Eighty percent (80%) of patients are uninsured or are covered by Medicaid.

<u>Revenue Bond of Sabine Parish Waterworks District No. 1, State of Louisiana; and Providing for Other Matters in Connection Therewith</u>

Resolution No. 9515

The following resolution was offered by Ruffin and seconded by Bison:

RESOLUTION

A resolution approving the issuance, sale and delivery of a Taxable Excess Revenue Bond of Sabine Parish Waterworks District No. 1, State of Louisiana; and providing for other matters in connection therewith.

WHEREAS, the Board of Waterworks Commissioners of Sabine Parish Waterworks District No. 1, State of Louisiana (the "Board"), acting as the governing authority of Sabine Parish Waterworks District No. 1, State of Louisiana (the "Issuer"), by resolution adopted by the Board on March 5, 2024, has authorized the issuance of a not exceeding \$1,750,000 Taxable Excess Revenue Bond of the Issuer (the "Bond"), for the purpose of (i) paying costs of constructing and acquiring improvements, extensions, renovations and replacements to the drinking water system (the "System"), including equipment, fixtures and accessories therefor, a work of public improvement for the Issuer (the "Project"), and (ii) paying costs of issuance of the Bond, pursuant to and under the authority of R.S. 39:526 and the other applicable provisions of Part II of Chapter 4 of Subtitle II of Title 39 of the Louisiana Revised Statutes of 1950, as amended, and other constitutional and statutory authority, said Bond to be secured by the income and revenues derived or to be derived from the operation of the System; and

WHEREAS, the Issuer has requested this Police Jury approve the issuance, sale and delivery of the Bond; and

WHEREAS, as required by Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, it is now the wish of this Police Jury to approve the issuance of the Bond;

BE IT RESOLVED by the Police Jury of the Parish of Sabine, State of Louisiana (the "Governing Authority"), acting as the governing authority of the Parish of Sabine, State of Louisiana (the "Parish"), that:

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of Waterworks Commissioners of the Issuer, this Police Jury hereby approves the issuance and sale of a not exceeding \$1,750,000 Taxable Excess Revenue Bond of Sabine Parish Waterworks District No. 1, State of Louisiana, said Bond to be issued under the authority, for the purposes, and to be payable from the sources stated in the preamble hereto. The Bond shall mature not later than ten (10) years from the date thereof and will be non-interest bearing. The principal of the Bond shall be subject to complete forgiveness.

SECTION 2. Neither the Parish of Sabine nor this Police Jury shall be liable in any manner for the payment of the Bond.

16. <u>Consider Adopting a Twenty (20) Miles Per Hour Speed Limit on Hardy Road Located in Ward 1, Road District 18</u>

ORDINANCE 1 of 2024

AN ORDINANCE ESTABLISHING A TWENTY (20) MILES PER HOUR SPEED LIMIT ON HARDY ROAD IN ROAD DISTRICT 18 (WARD 1)

WHEREAS, the Sabine Parish Police Jury is responsible for the safety of individuals traveling on parish roads, and

WHEREAS, the current posted speed limit for Hardy Road, located in Road District 18 (Ward 1), allows drivers to travel at speeds of up to forty-five (45) miles per hour without being issued a citation, and

WHEREAS, the Sabine Parish Police Jury has determined that this is a dangerous speed for travel on Hardy Road in Road District 18 (Ward 1)

NOW THEREFORE BE IT ORDAINED, that the maximum speed limit for any vehicle travelling on Hardy Road in Road District 18 (Ward 1) shall be twenty (20) miles per hour.

BE IT FURTHER ORDAINED, that this ordinance shall be in effect March 31, 2024, and it shall be published one time in the Official Journal of the Parish of Sabine, State of Louisiana, along with any other minutes of the meeting.

17. <u>Introduce an Ordinance Authorizing a Claim of Ownership of Adjudicated Property to the Sabine Parish Police Jury Pursuant to LA. R.S. 47:2236, Et Seq.: and Further Providing with Respect Thereto</u>

The Secretary Treasurer read the following proposed ordinance aloud.

ORDINANCE NO. 2 of 2024

AN ORDINATNCE AUTHORIZING A CLAIM OF OWNERSHIP OF ADJUDICATED PROPERTY TO THE SABINE PARISH POLICE JURY PURSUANT TO LA. R.S. 47:2236, ET SEQ.; AND FURTHER PROVIDING WITH RESPECT THERETO:

WHEREAS, La. R.S. 47:2236 authorizes the claim of full ownership of adjudicated properties for purposes allowed by the Louisiana Constitution;

WHEREAS, both the three (3) year period for redemption provided by Art. 7, §25 of the Louisiana Constitution on the adjudicated property referenced herein and the five (5) year redemption period

established by Parish Ordinance No. 1 of 2017 have elapsed, and the owner of record has failed to redeem the adjudicated property; and

WHEREAS, La. R.S. 47:2236 authorizes the political subdivision to claim full ownership of said property;

WHEREAS, the Sabine Parish Police Jury ("SPPJ") has a desire to claim full ownership of the following property described as Parcel 9104000100: Lots 1-2 of Block 29 of Town of Converse-Sec 10-9-13, Sabine Parish, LA that has long been abandoned and adjudicated to the Sabine Parish Police Jury for the purpose of use thereon:

WHEREAS, the Sabine Parish Police Jury finds that such acquisition is in the public interest and in accordance with applicable law;

NOW, THEREFORE:

BE IT ORDAINED that the Sabine Parish Police Jury does hereby declare its intent to acquire full ownership interest of the adjudicated property identified above upon completion of the procedures for adjudicated property pursuant to La. R.S. 47:2236, *et seq.*;

BE IT FURTHER ORDAINED, that the President of the Sabine Parish Police Jury be, and hereby is authorized to execute such documents as are reasonable and necessary to complete the acquisition as described above.
