Mr. Stanley Cook, Deputy Coroner - Report on the Coroner's Office Activities During the Period of January Through March 2024 and Discuss Coroner's Request for Equipment Mr. Stanley Cook, Deputy Coroner, reported on the activities and accomplishments of the Sabine Parish Coroner's Office during the first quarter of 2024.

Mr. Cook reported that the Coroner's Office received 178 calls of service during the first quarter of 2024. The Office worked 89 deaths, committed 56 individuals, and worked 33 cremation investigations.

Mr. Cook requested additional equipment for the Coroner's Office. He stated in order to improve safety performance, the office was requesting steel shank boots, knee pads, headlamps, and body cameras. He stated that the total cost of the additional equipment would be approximately \$3,300.

The following resolution was offered by Byrd and seconded by Bison:

RESOLUTION

A resolution approving the issuance, sale and delivery of not exceeding Two Hundred Fifty Thousand Dollars (\$250,000) of Limited Tax Bonds, Series 2024, of Wards 1 and 2 Fire Protection District No. 1 of the Parish of Sabine, State of Louisiana.

WHEREAS, Wards 1 and 2 Fire Protection District No. 1 of the Parish of Sabine, State of Louisiana (the "District"), propose to issue not exceeding \$250,000 of Limited Tax Bonds, Series 2024 (the "Bonds") for the purpose of constructing and improving fire protection facilities for the Issuer, including purchasing fire fighting equipment for the Issuer and paying costs of issuance of the Bonds; and

WHEREAS, the Bonds are payable from a pledge of the revenues to be derived by the District from the levy and collection of a tax of ten and twenty-four hundredths (10.24) mills to be levied through the year 2028, pursuant to an election held therein on April 29, 2017, and the pledge of revenues to be derived by the District from the levy and collection of a tax of eight and fifty hundredths (8.50) mills to be levied through the year 2031, pursuant to a special election held therein on April 24, 2021 (collectively, the "Tax"); and

WHEREAS, as required by Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, it is now the desire of this Police Jury to approve the issuance of said Bonds of the District;

NOW, THEREFORE, BE IT RESOLVED by the Police Jury of the Parish of Sabine, State of Louisiana, acting as the governing authority of the Parish of Sabine, State of Louisiana, that:

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of Commissioners of Wards 1 and 2 Fire Protection District No. 1 of the Parish of Sabine, State of Louisiana, this Police Jury hereby approves the issuance, sale and delivery of not exceeding \$250,000 of Limited Tax Bonds, Series 2024, of the District, the Bonds to mature not later than March 1, 2029, bear interest at a rate or rates not exceeding 4.50% per annum and to be secured by and payable from a pledge of the revenues to be derived by the District from the Tax.

SECTION 2. Neither the Parish of Sabine nor this Police Jury shall be liable in any manner for the payment of said Bonds, and no funds of the Parish nor of the Police Jury shall be pledged to the payment thereof.

Consider a Resolution Approving a Sales and Use Tax Payment in Lieu of Tax Agreement in Accordance with Amended Term Sheet; Requesting the Northwest Louisiana Finance Authority Execute an Amended Term Sheet and Execute an Amended Payment in Lieu of Tax Agreement in Conformity Therewith; and Providing for Other Matters with Respect Thereto

Resolution No. 9540

A RESOLUTION APPROVING A SALES AND USE TAX PAYMENT IN LIEU OF TAX AGREEMENT IN ACCORDANCE WITH AMENDED TERM SHEET; REQUESTING THE NORTHWEST LOUISIANA FINANCE AUTHORITY EXECUTE AN AMENDED TERM SHEET AND EXECUTE AN AMENDED PAYMENT IN LIEU OF TAX AGREEMENT IN CONFORMITY THEREWITH; AND PROVIDING FOR OTHER MATTERS WITH RESPECT THERETO.

WHEREAS, the Northwest Louisiana Finance Authority ("NWLFA") is a statutorily authorized local public trust permitted to acquire and hold property for one or more of its public purposes as set forth in R.S. 9:2341(B), which property is exempt from all taxes of the Parish, the State of Louisiana (the "State"), or any political subdivision thereof or any other taxing body; and

WHEREAS, NWLFA previously arranged to acquire a solar photovoltaic facility (the "Solar Project") and potentially an optional Energy Storage facility (the "Optional Energy Storage Project," and together with the Solar Project, the "Project") in the Parish of Sabine (the "Parish") pursuant to a Term Sheet issued to Hollis Creek PV I, LLC (the "Term Sheet"); and

WHEREAS, pursuant to the Term Sheet, NWLFA intends to lease the Project to Hollis Creek PV I, LLC (the "Lessee"), a limited liability company organized and existing under the laws of the state of Delaware and qualified to do business in the State, which will pay annually a sum in lieu of ad valorem taxes in an amount not to exceed the amount of taxes that would otherwise be due if the Project were not owned by the NWLFA (a "PILOT"); and

WHEREAS, the Lessee now desires to amend the Term Sheet to provide for a sales and use tax Payment in Lieu of Tax ("Sales Tax PILOT") agreement whereby the NWLFA will designate the Lessee as its agent for purposes of purchasing machinery and equipment to be used in the construction and operation of the Project, to provide for a reduction in sales and use taxes associated with the Project ("Amended Term Sheet"); and

WHEREAS, the Sabine Parish Police Jury must finds and determines that such a Sales Tax PILOT is necessary for the Project and will provide benefits to the Parish.

NOW, THEREFORE, BE IT RESOLVED by the Police Jury of the Parish of Sabine that:

<u>Section 1.</u> The foregoing whereas clauses are hereby adopted as set forth in the preamble to this Resolution.

Section 2. This Parish does hereby approve the Sales Tax PILOT and Amended Term Sheet for the Project, in accordance with the Amended Term Sheet and requests approval by NWLFA

Section 3. The President and Secretary-Treasurer are hereby authorized, empowered, and directed to take forthwith any and all such action as may be necessary to carry into effect the provisions of this Resolution.

Section 4. If any one or more of the provisions of this Resolution shall for any reason be held to be illegal or invalid, such illegality or invalidity shall not affect any other provision of this Resolution, but this Resolution shall be construed and enforced as if such illegal or invalid provisions had not been contained herein. Any constitutional or statutory provision enacted after the date of this Resolution which validates or makes legal any provision of this Resolution which would not otherwise be valid or legal, shall be deemed to apply to this Resolution.

Section 5. This Resolution shall immediately take effect upon adoption.

AN ORDINATNCE AUTHORIZING A CLAIM OF OWNERSHIP OF ADJUDICATED PROPERTY TO THE SABINE PARISH POLICE JURY PURSUANT TO LA. R.S. 47:2236, ET SEQ.; AND FURTHER PROVIDING WITH RESPECT THERETO:

WHEREAS, La. R.S. 47:2236 authorizes the claim of full ownership of adjudicated properties for purposes allowed by the Louisiana Constitution;

WHEREAS, both the three (3) year period for redemption provided by Art. 7, §25 of the Louisiana Constitution on the adjudicated property referenced herein and the five (5) year redemption period established by Parish Ordinance No. 1 of 2017 have elapsed, and the owner of record has failed to redeem the adjudicated property; and

WHEREAS, La. R.S. 47:2236 authorizes the political subdivision to claim full ownership of said property;

WHEREAS, the Sabine Parish Police Jury ("SPPJ") has a desire to claim full ownership of the following property described as Parcel 9104000100: Lots 1-2 of Block 29 of Town of Converse-Sec 10-9-13, Sabine Parish, LA that has long been abandoned and adjudicated to the Sabine Parish Police Jury for the purpose of use thereon:

WHEREAS, the Sabine Parish Police Jury finds that such acquisition is in the public interest and in accordance with applicable law;

NOW, THEREFORE *BE IT ORDAINED*, that the Sabine Parish Police Jury does hereby declare its intent to acquire full ownership interest of the adjudicated property identified above upon completion of the procedures for adjudicated property pursuant to La. R.S. 47:2236, *et seq.*;

BE IT FURTHER ORDAINED, that the President of the Sabine Parish Police Jury be, and hereby is authorized to execute such documents as are reasonable and necessary to complete the acquisition as described above.
