Mr. Stanley Cook, Deputy Coroner, reported on the activities and accomplishments of the Sabine Parish Coroner's Office during the second quarter of 2025.

Mr. Cook reported that the Coroner's Office received 133 calls of service during the second quarter of 2025. The Office worked 55 deaths, committed 60 individuals, and worked 18 cremation investigations.

The Road Superintendent informed the committee he had obtained prices for both Pliler International (International) and Caterpillar (CAT) diagnostics systems. The International system includes an initial software cost of \$1,200 and a recurring annual subscription cost of \$900. CAT's system requires an initial software cost of \$1,300 and a recurring annual subscription cost of \$1,500. The committee agreed the parish mechanics could benefit from the equipment and increase the possibility of keeping all repairs and maintenance of parish machinery in-house rather than relying on outsourcing. The committee recommended purchasing both International and CAT diagnostic equipment.
