The first step in this process is introducing an ordinance for this purpose. Secretary Treasurer Weatherford then read the proposed ordinance name aloud.

ORDINANCE NO. 10 of 2025

AN ORDINANCE MERGING CERTAIN PRECINCTS CONTAINING LESS THAN 300 REGISTERED VOTERS AND AMENDING THE TERRITORIAL LIMITS AND DESIGNATIONS OF THOSE CERTAIN PRECINCTS, IN COMPLIANCE WITH LOUISIANA REVISED STATUTES, WITHIN THE PARISH OF SABINE, STATE OF LOUISIANA

19. Ratify Emergency Hiring of Superintendent for the Solid Waste Landfill

Mr. Pete Chreene Jr. resigned as Superintendent of the Solid Waste Landfill effective August 26, 2025. He was the only employee of the Sabine Parish Police Jury to hold a Class A Operator's license. The Jury must have an employee with a Class A License to operate the landfill. The opportunity to hire Mr. James "J.C." Holman who holds a Class A Operator's License, arose on October 31, 2025. The Solid Waste Committee unanimously recommended hiring James "J.C." Holman effective November 1, 2025.

Resolution No. 9888

Motion by Remedies and seconded by Byrd:

WHEREAS, Mr. Pete Chreene Jr., Superintendent of the Solid Waste Landfill resigned effective August 26, 2025, and

WHEREAS, the Police Jury must have an employee with a Class A Operator's License to operate the landfill, and

WHEREAS, the Solid Waste Committee unanimously recommended hiring Mr. James "J.C." Holman as Superintendent of the Solid Waste Landfill effective November 1, 2025, because of the emergency arising because of Mr. Pete Chreene's resignation

NOW BE IT RESOLVED, that the Sabine Parish Police Jury hereby ratifies the emergency hiring of Mr. James "J.C." Holman as Superintendent of the Solid Waste Landfill, and

BE IT FURTHER RESOLVED that Mr. Holman will be hired effective November 1, 2025, with an annual salary of \$90,000.00, and

BE IT FURTHER RESOLVED that Mr. Holman will not participate in the STEP Program but will be eligible to participate in all other employee benefits normally offered to Police Jury employees, and

BE IT FURTHER RESOLVED that the Police Jury will provide Mr. Holman with full health insurance coverage should he choose to participate in the Jury's current PPO benefit plan.

The current inbound scales located at the Solid Waste Landfill are worn and starting to deteriorate. To continue running efficiently, the Police Jury needs to replace the inbound scales as soon as possible. Replacing the scales will restore continuous inbound/outbound weighing capacity and reduce operational delays at the landfill.

BE IT FURTHER RESOLVED that the Secretary Treasurer is directed to advertise for public bids for the purchase of inbound scales installed and completely ready for operation at the Solid Waste Landfill.
